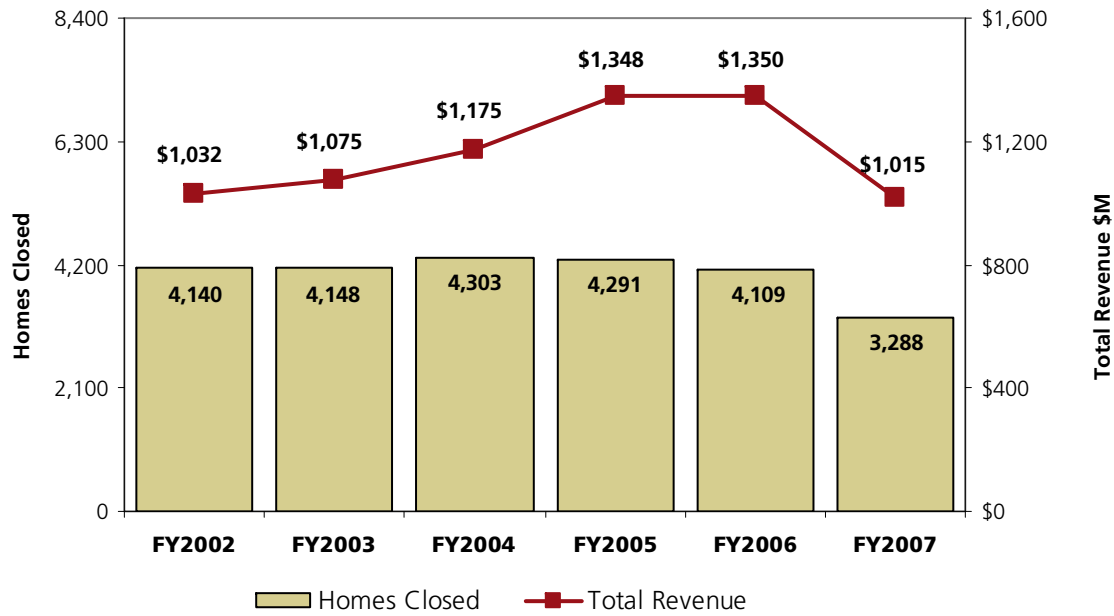
About Founded in 1976, M/I Homes constructs single-family homes, attached town homes, and condominiums for first-time, move-up, empty-nester, and luxury buyers under the M/I Homes and Showcase Homes trade names. The company supports its home building operations with mortgage financing services and title and insurance brokerage services through subsidiaries that are either wholly or majority owned. Thus, the company's segments include Midwest home building, Florida home building, Mid-Atlantic home building, and financial services. At the close of 2007, M/I Homes announced that it had sold land to various buyers for \$82 million, primarily in the Florida markets, and included substantially all of the company's West Palm Beach assets, representing over 500 lots in four communities. In connection with this sale, the company also announced that it was exiting the West Palm Beach market.
